Statutory Context

NPC Members who are juristic bodies must disclose to the NPC if, subsequent to their application for membership they come under "common ownership" or "common control" of certain persons in relation to other juristic bodies who are either members of the NPC or eligible for such membership.

- "Common ownership" in relation to two or more juristic bodies who are eligible for membership of the NPC company means greater than 50% ownership of each such body by any person.
- "Common control" in relation to two or more juristic bodies who are eligible for membership of the management body of a CID, means control of the first-mentioned bodies by a person who-
- (a) beneficially owns more than half of the issued share capital of each body:
- (b) is entitled to vote a majority of the votes that may be cast at a general meeting of each body, or has the ability to control the voting of a majority of those votes, either directly or through a controlled entity of that person;
- (c) is able to appoint or to veto the appointment of a majority of the directors of each body;
- (d) is a holding company and each body is a subsidiary of that company;
- (e) in the case of a body which is a trust, has the ability to control the majority of the votes of the trustees, to appoint the majority of the trustees or to appoint or change the majority of the beneficiaries of the trust;
- in the case of a close corporation, owns the majority of the members' interest or controls directly or has the right to control the majority of the members' votes in the close corporation; or
- has the ability to materially influence the policy of the bodies in a manner comparable to a person who, in the ordinary commercial practice, can exercise an element of control referred to in para (a) to (f) of this definition.
